



Corporate Volume 3% Rebate Program

Assists Resellers in Closing Large Sales to Corporate End Users

Eligible Sales

To qualify, a **single** corporate customer must place an order for **ten** (10) units or more of an eligible hardware product (see list below) and take delivery of all units within a 90 day period.

- Accessories (scanner cartridges, batteries, etc.) purchased with hardware products are eligible for rebate dollars, but will **not** count towards meeting the unit quantity requirements.
- Supplies (ink, toner, specialty papers, etc.) are **not** eligible for rebate dollars.

Rebate Amount

Rebate amount is **3%** of the purchase price from the Consumer Imaging Group of Canon U.S.A., Inc. (“Canon”) or Canon’s authorized distributor. Orders from different corporate customers may NOT be combined to earn rebate dollars.

Procedure to Claim a Rebate

Resellers who purchase product to fulfill an order directly from Canon must do the following once the product has been delivered to the end user.

1. Complete the attached Corporate, Government and Education Rebate Claim Form.
2. **Fax** a copy of the completed claim form with a copy of the invoice(s) to the end user or a point of sale report from reseller’s automated system to **516.328.4440**.
3. The reseller will receive a rebate credit to their account with Canon. Please allow three (3) weeks for the credit.

Resellers who purchase product to fulfill an order from an authorized Canon Distributor will receive their rebate from the Distributor. Because the Distributor may build the rebate into the price, please be sure to inform the Distributor up front that the purchase is for a Corporation and inform the Distributor that you want to take advantage of Canon’s Corporate Volume Rebate Program.
